**PROGRAM DESCRIPTION**

The Incentive Scholarship and Grant Program for Native Americans (ISGPNA) is a state-funded program created in 1995 by a merger of the American Indian Student Legislative Grant Program and the Incentive Scholarship Program for Native Americans. The purpose of the program is to increase the enrollment of Native Americans at the constituent institutions of The University of North Carolina.

**UNDERGRADUATE STUDENTS**

To be eligible for the Incentive Scholarship and Grant Program for Native Americans, undergraduate students must meet the following requirements:

- Be classified as a **North Carolina resident** for tuition purposes
- Be admitted/enrolled in an undergraduate degree-granting program
- Complete the Free Application for Federal Student Aid (FAFSA), found online at <http://www.fafsa.gov>. UNCG's priority filing deadline for the FAFSA is January 15th. Applicants must show need based on the FAFSA data using Federal Methodology.
- Be classified as a Native American in UNCG student records
- Provide a **tribal membership card or letter of certification** from a tribe recognized by the State of North Carolina or the federal government. Before ISGPNA funds can be disbursed, the University must receive clearance on the tribal documentation from the North Carolina Commission of Indian Affairs.
- Complete the **Application for Incentive Scholarship and Grant Program for Native Americans** and return it to the Office of Financial Aid and Scholarships.
- Be enrolled in at least **6 semester hours** each semester. Preference will be given to full-time students.
- Maintain good academic standing with the University. You must also meet the financial aid requirements as noted in the satisfactory academic progress policy. The *Satisfactory Academic Progress Policy* can be found online at [spartancentral.uncg.edu](http://spartancentral.uncg.edu).
